Student Learning Outcomes/Objectives

- 1. To develop the student's basic communication skills. 2. To develop the student's interpersonal and critical listening skills. 3. To develop the student's public speaking skills.

11. The student should be able to use automated indexes and/or other electronic research media to research speech topics.

12. The student should be able to complete a written analysis of communication patterns in family, social, or business situations.
13. The student should be able to complete a written analysis of a contemporary speech.
14. The student should be able to complete a written analysis of his/her own communication activities and skills.

Instructional Approach and Methods

Much class time will be devoted to communication exercises and public speaking activities. Class time will also be used for lecture/discussion on course topics covered in the text and class handouts. Class discussion and student participation in class activities will be stressed.

- Students will be evaluated based on their performance on objective tests.
- Students will be evaluated based on their performance delivering oral presentations.
 - group narrative speech/panel discussion
 - speech to inform/visual aids
 - speech to persuade/critical issue
- Students will be evaluated based on written folder assignments. All folder assignments must be typed and submitted to eLearn dropbox.

Assessment, Evaluation and Testing Procedures

1. Exams will be drawn from textbook and class notes. Questions will be multiple-choice.
2. All exams must be taken on the days scheduled. If a student misses an exam due to illness the student should contact the instructor immediately upon his/her return to schedule a makeup exam.
3. No makeup exams will be given except in cases of documented personal illness, emergencies or a WSCC technology glitch.

Class Participation

1. Students are expected to attend all designated classes. A major focus of COMM 2025 is the development of communication skills. Class attendance and participation in class activities are absolutely essential to the student's ultimate success in the course. Failure to attend class and participate effectively in class exercises may result in a failing grade for the course. Attendance, student reading, and out-of-class activities ("homework") are all important.
2. Attendance will be taken, either with the class roll or through assignments. Students missing more than nine class hours will fail the course. Arriving late or leaving early will count as at least one half day absence. This policy translates as follows:
 - For a 1-night per week summer class, you may not miss more than two classes.
 - Students are encouraged to not miss any class session or assignment as habitual absences are closely linked to lack of success in this course.

3. Communication exercises and group discussions conducted in class cannot be made up outside of class.
4. Although class activities missed because of absence cannot be made up, a limited amount of make-up work will be available for excused absences (illness or family emergency). No makeups will be allowed for unexcused absences. It is the student's responsibility to contact the instructor regarding missed work.
5. Behaviors related to attendance and participation – such as frequent absences or tardiness, distracting or inappropriate class conduct, or the failure to complete assignments and speeches on time – may significantly lower the student's grade.

Course and Class Policies/Procedures

Policy on Visual Aids for the Classroom:

1. Students should select topics appropriate to the assignment, the audience and the classroom setting. The selection of visual aids for use with speeches requiring a visual aid should be made with the same careful consideration to audience and setting.
2. Any visual aids brought to class should aid in the explanation of the topic and not in any way detract from the speech or class decorum. Students should under no circumstances bring to the classroom weapons of any type (whether operable or inoperable) or other items such as ammunition, pressurized canisters, hazardous chemicals or flammable liquids. Also, animals, including house pets, should not be brought to class.
3. Students should consider the use of pictures or digital PowerPoint images for topics that could involve the use of any prohibited visual aids. The student must assume the responsibility for any harm or damage that might occur to persons or property from the student's use of the visual aid.

Policies on Exams, Assignments, Documentation, and Plagiarism:

1. Exams will be drawn from the readings, class notes, and videos, and will be primarily multiple-choice and short answer. All exams must be taken on the days scheduled. If a student misses an exam due to illness the student should contact the instructor immediately upon his/her return to campus to schedule a makeup exam. No makeup exams will be given except in cases of documented personal illness or emergencies. Makeup exams must be completed within one week.
2. All assignments and speeches must be completed on or by the assigned date. A late penalty will be assessed at 25% per day for all work not completed on time. Speeches missed due to

unexcused absences cannot be made up. All written assignments must be typed or word-processed.

3. All speeches must be documented with a works cited list in accepted bibliographical form.
4. All materials turned in for COMM 2025 become the property of the Communication Department.
5. All forms of cheating, plagiarism, and academic dishonesty are strictly prohibited. All speeches, papers, and assignments for the course should be the student's original work according to guidelines governing the assignment. The penalty for cheating and plagiarism on tests, speeches, or written assignments is a grade of zero and referral to the WSCC administration for any institutional penalties. Repeated violations can result in a grade of 'F' for the course.

Additional Course Requirements/Details/Information

Criteria for Oral Presentations (specific criteria checklist given in class)

1. The speech thesis must be clear and clearly stated. The speech must be well organized with an introduction, preview, transitions, and summary.
2. The speech must be presented with effective vocal qualities including volume, emphasis, and clear articulation.
3. The student must use good eye contact with the audience and explain points directly to the audience in his/her own words using sketch notes on index cards.
4. The student must exhibit neat and professional dress.
5. The speech must be the student's own work and presented in the student's own words.
6. The research done for the speech should be based on current information available from books, magazines, journals, the internet, and interviews of knowledgeable individuals.
7. The speech must use neat, clearly visible, and appropriate visual aids to clarify points. (Visual aids are required for the informative speech.)
8. The student must present research with the speech, including an outline and bibliography.
9. The speech must be given when due.

10. The speech must be interesting or enjoyable as it explores the topic sufficiently in the time allotted (informative speech), or it must effectively argue one side of an issue or present a problem and offer solutions (persuasive/argumentation speech).
11. The speech must not be offensive to particular individuals in content, language, or manner.

Academic Honesty

Faculty expect all students to refrain from acts of academic misconduct including but not limited to:

1. Plagiarism - refers to using another person's ideas or writing without giving proper credit to the original source. Indulging in this type of conduct will subject the student to disciplinary sanctions, which may be imposed through the regular institutional procedures of Walters State Community College as outlined in the Student Handbook. Plagiarism will result in a grade of "0" for the paper/exam/presentation. Student Conduct and Disciplinary Sanctions contained in the college Catalog/Student Handbook apply (see policy 04:18:02 Disciplinary Sanctions).

Plagiarism includes, but is not limited to the following:

- a. Using cut/paste tool from original document with no references given.
 - b. Copying another student's work and submitting it as one's own.
 - c. Forging or otherwise altering signatures.
 - d. Giving or falsifying academic documents or materials.
2. Cheating - construed as attempting to deceive or mislead which includes, but is not limited to the following:
 - a. Utilizing old tests, projects, notes or written papers.
 - b. Providing unauthorized information to a fellow student about exam content.
 - c. Receiving unauthorized aid from any source with quizzes, examinations, or other assignments.
 - d. Seeking information in an unacceptable manner during/preceding an exam or other assigned work (cheat sheet, verbal exchange, looking at another person's paper or electronic device, utilizing headphones, using textbook when the test/quiz is not an open book test/quiz, using textbook test bank etc.).
 - e. Consulting with a classmate or others when taking a computerized test.
 - f. Disregarding other specific policies and procedures outlined for a particular class.
 - g. Utilizing unapproved technology/electronic equipment during testing (i.e.: mobile devices such as cell phones, smart devices, or tablets, etc.).
 - h. Using the same Internet Protocol network address (IP address) as another student for testing without approval from the course faculty.

COURSE GROUND RULES

- Students must attend the first day of on-ground class or contact the instructor prior to the first class. Failure to do this may result in being dropped from the class. Excessive absences may substantially lower the course grade.
- Regular class attendance is a student's obligation for any course regardless of format. (See the Walters State Catalog/Student Handbook). If a student misses class, it is his or her responsibility to contact the instructor regarding missed assignments and/or activities and to be prepared for the next class assignment.
