Instructional Approach and Methods

Much class time will be devoted to communication exercises and public speaking activities. Class time will also be used for lecture/discussion on course topics covered in the text and class handouts. Class discussion and student participation in class activities will be stressed. ELearn will be used throughout the course.

- 1. Students will be evaluated based on their performance on objective tests.
- 2. Students will be evaluated based on their performance in delivering oral presentations.

- 3. Students will be evaluated based on written assignments and folder assignments. All written/folder assignments must be typed in Word document format.
- 4. Students will be evaluated based on their class participation.
- 5. Students will be evaluated based on their attendance.

Assessment, Evaluation and Testing Procedures

- Exams will be drawn from the readings, class notes, and videos, and will be primarily multiplechoice. All exams will be given online via eLearn unless circumstances require a physical exam.
- All exams must be taken on the day scheduled. If a student misses an exam due to illness the student should contact the instructor immediately upon his/her return to campus to schedule a makeup exam.
- 3. No makeup exams will be given except in cases of documented personal illness or emergencies.
- 4. Makeup exams must be completed within one week.
- 5. Criteria for Oral Presentations (specific criteria checklist given in class)

- 1. The speech thesis must be clear and clearly stated. The speech must be well organized with an introduction, preview, transitions, and summary.
- 2. The speech must be presented with effective vocal qualities including volume, emphasis, and clear articulation.
- 3. The student must use good eye contact with the audience and explain points directly to the audience in his/her own words using sketch notes on index cards.
- 4. The student must exhibit neat and professional dress.
- 5. The speech must be the student's own work and presented in the student's own words.
- 6. The research done for the speech should be based on current information available from books, magazines, journals, the internet, and interviews of knowledgeable individuals.
- 7. The speech must use neat, clearly visible, and appropriate visual aids to clarify points. (Visual aids are required for the informative speech.)
- 8. The student must present research with the speech, including an outline and bibliography.
- 9. The speech must be given when due.
- 10. The speech must be interesting or enjoyable as it explores the topic sufficiently in the time allotted (informative speech), or it must effectively argue one side of an issue or present a problem and offer solutions (persuasive/argumentation speech).
- 11. The speech must not be offensive to particular individuals in content, language, or manner.

Students failing to complete all assignments, tests, and speeches may receive an F for the course. Students must satisfactorily complete the final/persuasive speech in order to receive a passing grade in the course

Assignments

- Panel Discussion -- Student prepares and presents a 4-5 minute research-based discussion on a broad Communication topic as a part of a student panel.
- Speech to Inform/Visual Aids---Student prepares and presents a 4-5 minute research-based Informative Speech using supporting visual aids such as PowerPoint.
- Speech to Persuade/Critical Issue--Student prepares and presents a 5-6 minute research-based Speech to Persuade/Critical Issue on a current issue.
- Student completes written Communication Folder assignments, including Communication Goal, Self-Concept Analysis, Empathic Listening Essay, Family Communication Analysis, Persuasive Message/Advertisement Analysis, and Political Speech Analysis.

Class Participation

- 1. Students are expected to attend all designated classes. A major focus of COMM 2025 is the development of communication skills. Class attendance and participation in class activities are absolutely essential to the student's ultimate success in the course. Failure to attend class and participate effectively in class exercises may result in a failing grade for the course. Attendance, student reading, and out-of-class activities ("homework") are all important.
- 2. Communication exercises and group discussions conducted in class cannot be made up outside of class.
- 3. Although class activities missed because of absence cannot be made up, a limited amount of make-up work will be available for excused absences (illness or family emergency). No makeups will be allowed for unexcused absences. It is the student's responsibility to contact the instructor regarding missed work.
- 4. Behaviors related to attendance and participation such as frequent absences or tardiness, distracting or inappropriate class conduct, or the failure to complete assignments and speeches on time may significantly lower the student's grade.

Course and Class Policies/Procedures

The instructor has primary responsibility for control over classroom behavior and maintenance of academic integrity and can order the temporary removal or exclusion from the classroom of any student engaged in disruptive conduct or conduct in violation of the general rules and regulations of

the institution. Extended or permanent exclusion from the classroom or further disciplinary action can be effected only through appropriate procedures of the institution.

Classroom Behavior Policy:

Students are expected to be positively engaged in class lectures, group discussions and student speeches. Students should show respect to the instructor and to other students. Any behavior which may distract from the learning process should be avoided. The behaviors listed below may affect the student's final course grade:

- 1. Arriving for class late.
- 2. Leaving class early.
- 3. Sleeping during class.
- 4. Attending to a cell phone or laptop computer.
- 5. Private conversations with classmates.
- 6. Blurting out comments.

Students exhibiting these behaviors will be given a Classroom Misconduct Report and asked to meet with the instructor.

Cellular phones and digital devices:

Cellular phones, headphones, and all digital devices MUST BE PLACED ON SILENT during class. If these disrupt the class the owner will be asked to leave. Laptop computers and tablets may be used only with the permission of the instructor.

Attendance Process and Policy:

Attendance will be noted in this class. Attendance and online discussion posts are worth 10% of the overall course grade and is expected and will be recorded.

The instructor will check and reply to eLearn e-mail as quickly as possible. Please allow up to 24-48 hours.

Procedure for Submission of Work:

All work for this class, unless otherwise noted, will be submitted digitally online via eLearn or some other digital method. Students will not be notified if work is not submitted. It is the student's responsibility to submit their work in a timely manner.

Testing Procedures:

All exams will be given online via eLearn unless circumstances require a physical exam.

Grading and Work Return Procedures and Evaluation Process:

Speeches will be worth 40% of the overall course grade and will be graded based upon a review of the performance and aspects of the speeches. Students will receive in a timely manner a digital critique sheet listing improvement areas, strengths, and the grade of their speech. This critique sheet will be delivered via et earn e-mail unless otherwise noted.

Exams will be worth 40% of the overall course grade and will be graded digitally via eLearn unless circumstances require a physical exam. Students will receive their grade instantly after the completion of their exam online.

The Speech Folder is worth 10% of the overall course grade and will be graded based upon a review of the digital speech folder provided to the instructor via eLearn. After grading is completed students will receive in a timely manner a digital graded copy of their speech folder via eLearn.

Attendance and Participation is worth 10% of the overall course.

COURSE GROUND RULES

- Students must attend the first day of on-ground class or contact the instructor prior to the first class. Failure to do this may result in being dropped from the class. Excessive absences may substantially lower the course grade.
