Student Learning Outcomes/Objectives

- 1. Find antiderivatives of functions including methods involving u-substitution, completing the squares, partial fractions, trigonometric substitution, and tables of integrals.
- 2. Use the Fundamental Theorem of Calculus to evaluate definite integrals.
- 3. Approximate definite integrals using the numerical methods (right-hand rectangles, left-hand rectangles, midpoint rectangles, trapezoid rule, and
- 4. Find area using polar coordinates.
- 5. Use integrals to solve applied problems including areas, volumes of solids of revolution, and arc length.
- 6. Evaluate improper integrals.
- 7. Test for absolute and conditional convergence of infinite series including geometric series, the Integral Test, the Comparison Test, the Limit
- 8. Express functions as power series and find the radius of convergence.
- 9. Use calculator and/or computer software appropriately when working calculus problems.

Instructional Approach and Methods

The class will meet M-R from 9:00 am - 12:05 pm in MBSS 226. Each day, the class will also be live-streamed through Teams. Attendance is expected either in person or in Teams for each class meeting. This class is listed as a hybrid. The definition of hybrid that we are using is that all exams must be taken in person on campus.

You will be counted as having attended the class once you have completed the Introduction to MyOpenMath.

The last date of attendance will be the last day that you worked in MyOpenMath or the final exam date.

Assessment, Evaluation and Testing Procedures

<u>Cell Phones</u>: Cellular phone use during classroom interaction is prohibited. If a cell phone is handled or used during an exam without the instructor's permission, the instructor may give a zero grade for the exam.

<u>Attendance</u>: Attendance is vital for successful completion of the course!

Extra Credit: No extra credit will be given in this college level course.

<u>Homework</u>: Homework assignments are to be done after a topic is covered. Homework is administered through MyOpenMath inside eLearn. Here you have an unlimited number of attempts on the homework.

Exams: There will be three (3) in-class exams and a comprehensive final exam.

If all three in-class exams are taken and one in-class exam score is lower than the final exam then the final exam score will replace the lowest in-class exam score.

If one in-class exam is missed then the final exam score will replace the missed in-class exam score. If more than one in-class exam is missed, the first missed exam score will be replaced by the final exam score and scores of zero (0) will be given for the additional missed exams.

Exceptions for making up a missed exam will be given for documented school sponsored events or approved military duty. (See the procedure for documented school sponsored events or military duty.)

If a student arrives late to take an in-class exam and other students have already completed the exam and left the room, the student arriving late may not be allowed to take the exam. If not then the exam will be counted as a missed exam.

<u>Honors Students</u>: Honors students must successfully complete all honors assignments on time <u>and</u> must make a grade of A or B in the course to receive honors credit.

<u>Procedure for Documented School Sponsored Events:</u>

If an in-class exam is missed due to a documented school sponsored event, the student must contact Mr. Atkins <u>before</u> the scheduled absence and make arrangements to <u>take the exam early</u>. Failure to do so will result in the exam counting as a missed exam for calculating the average.

Procedures for Military Duty:

A student called to Active Duty Military Service should see the "WSCC Policies & Procedures" (04:02:00) for their options regarding course enrollment. In the case of a short-term Military Temporary Duty with the student able to return to class and complete the course, make-up work may be allowed. The student must provide appropriate documentation, including orders. If possible, the instructor and student will agree on the make-up procedures prior to departure.

<u>Final Exam</u>: The final exam will be given according to the schedule posted in the timetable of classes for this semester. For financial aid considerations, students should attend the final exam regardless of what the final grade in the class will be.

Assignments

- 1. **Homework**: Homework will be administered and graded through a free Open Education Research online homework program called MyOpenMath. Each section will contain a set of homework questions pertaining to the content in that section. The homework questions can be attempted an unlimited number of times. This homework is guided to prepare you for the exams. The homework average will count 10% of each exam grade.
- 2. Quizzes: There will be 2-4 quizzes on the content for each exam. These will be take home and due at the beginning of class either in person or in the dropbox. If the quiz is scanned to the dropbox, it must be scanned as one pdf document. All work must be shown on the quizzes in order for me to provide you good feedback. These assignments will count 15% of the overall semester grade.
- 3. **Exams**: There will be three (3) semester exams given during the semester. All exams must be proctored on campus. Options to test on a different campus are available. Discuss with me so that we can work out the details. If a student is going to be absent for an exam, arrangements should be made prior to the exam day to take that test. The exam average will count 55% of the overall semester grade.
- 4. Final Exam: There will be a cumulative final exam for the course. The final exam counts 20% of the overall semester grade. The final exam will be administered on the last regular day of class.
- 5. **Gateway Exam:** A student must make at least 80% on a copy of a Gateway Exam over integrals. This gateway does not count toward the overall semester grade, but a student cannot pass the class without successful completion of the gateway exam. The exam may be taken as many times as necessary before the final exam. The gateway exam does not have any weight toward the overall semester grade.

Semester Grade = 0.10*(HW) + 0.15*(QZ AVG) + 0.55*(Exam Avg) + 0.20*(final exam)

Class Participation

Being active in class will help you do so much better. On days when you are virtual, I **STRONGLY RECOMMEND** that you keep your cameras on to help you stay engaged. There may be opportunities for students to work questions for the class for extra credit points.

COURSE GROUND RULES
