This course is 100% online and does not meet in-person. Instructional methods may include course text, labs, simulations, videos, and written instructions. This course is **NOT** self-paced. Students must complete assigned items by the posted due date. Online content will be on the Cengage Platform. Instructions for accessing will be provided on the first day of classes.

Assessment, Evaluation and Testing Procedures

Evaluation Methods

Evaluation methods may include assignments, simulations, labs, quizzes, chapter exams, major exams, pre/post exam for course.

A grade of "F" will be assigned for any student conducting plagiarism, cheating, or other forms of academic dishonesty. See the Academic and Classroom Misconduct section in the college catalog.

Testing Procedures:

Exams will be taken on the Cengage Website and may not normally be made up except for the most extreme of circumstances (accidents, serious illness, etc.). Exams are not to be missed without a

documented excuse. A score of zero will be assigned for the exam missed. In the event of an emergency, it is the student's responsibility to contact the instructor before exam time. Minor illnesses of student or family members are not satisfactory excuses for missing an exam. An exam that is to be made up will require official documentation from the explaining the dire circumstances causing the absence. No make-up exam will be given to any student who misses the exam without documentation to the instructor. Make-up exams may be different from the regular test. Grade weightings and testing procedures are subject to change if changes to the course delivery format are required.

Assignments

Students will complete the required assignments as shown in Cengage for each corresponding chapter. Assignments will be evaluated based on their assigned number of points. Assignments are to be turned in on or before the due date. Late assignments will NOT be accepted.

IMPORTANT

It is each student's responsibility to make sure that the files they submit are their own. Also, they are to make sure that no other student has access to their files. If a student turns in a file prepared by another student, both students receive a grade of 0. A second occurrence is grounds for both students to receive an "F" in the course. Cheating on any assignment will result in a grade of 0 for that assignment. Repeated occurrence is grounds for the student to receive an "F" in the course. Cheating includes, but is not limited to: using, copying, or paraphrasing answers or solutions obtained from

another student, the internet, or any other source beyond materials provided in this course. Answer assignment questions in your own words.

Class Participation

Class Participation

Class topics, assignments, and some assessments are scheduled and taken using Cengage. It is the student's responsibility to review the main course page and grades areas in Cengage and determine the items that must be completed each week. All assignment due dates are posted on or before the first day of this class. It is also the student's responsibility to verify that all assignments and quizzes did get submitted properly and that accurate scores were posted in the Grades area of Cengage.

Attendance

Student attendance is recorded by submission of graded items. A student must make at least one submission of a graded item each week to be counted as attending for the week.

Students must submit at least one graded item by 5pm on Thursday of the first week of classes to be counted as "attending the first day of class" for the purposed of Financial Aid Attendance Reporting. Failing to do so may result in being dropped from the course. Any student that expects challenges accomplishing this should contact the instructor, Student Support Services, and the Financial Aid office to discuss possible problems.

Regular class attendance is a student's obligation for any course regardless of format. (See the <u>Walters State Catalog/Student Handbook</u>). It is a student's responsibility to review course items and to understand and comply with due dates. Excessive absences may substantially lower the semester grade. The college requires the instructor to keep accurate records and to report when students are not attending class. This includes courses that are 100% online.

In the event of **excused** absence, it is the student's responsibility to catch up with missing material as well as homework. There will be no make-up tests for unexcused absences. If any make-up test is given, it may be different from the regular test in content as well as format.

Examples of excused absences include, but are not limited to, personal illness, illness of a spouse, child, or close family member, bereavement, military reserves duties. Documentation is required in all cases. Faculty are not obligated to allow students to make up work missed due to unexcused absences
